Motion in support of CF #20-0838 / Permanent Slow Streets

On May 15, 2020, Mayor Eric Garcetti announced the Slow Streets Program in Los Angeles. This program - putting up temporary barriers at intersections asking cars to slow down and not cut through - has successfully led to many of our streets being calmer and having fewer cars, making them safer to walk, run, bike and scoot.

All over Los Angeles, cut through traffic is a constant issue, making our streets less safe and peaceful. Furthermore, during the COVID-19 stay at home order, many more people are walking, running, and biking in our streets, and our sidewalks are not wide enough to allow people to do so while maintaining recommended social distance guidelines.

Therefore, we would like to state our support for Council File 20-0838, and ask the City to make slow streets permanent. Lankershim Bl. protected bike lanes

WHEREAS the City of Los Angeles city council approved a "2035 Mobility Plan†in 2016;

WHEREAS treatment for Lankershim Bl. in the Mobility Plan includes a protected bike lane;

WHEREAS Los Angeles typically modifies street configurations during street repaving;

WHEREAS the "ADAPT†program by StreetsLA is dramatically accelerating the repaving of commercial corridors during the COVID-19 traffic lull;

WHEREAS Lankershim Bl. between Whipple St and Cahuenga Bl is scheduled to be repaved soon;

THEREFORE we ask that the Los Angeles Department of Transportation, in coordination with StreetsLA, implement the 2035 Mobility Plan as approved by the city council when repaving Lankershim BI, adding a parking protected bike lane on both sides of the street; we understand this may

require a lane reconfiguration, reallocating space from vehicle traffic to active transportation. If for any reason this is not possible then we ask that you delay repaving until such time that the mobility plan can be fully implemented.

If for any reason this is not possible then we ask that you delay repaving until such time that the mobility plan can be fully implemented.

The project includes \$36 million in street and sidewalk improvements that will make it safer, easier and more comfortable to walk, bike and ride transit around Canoga Park, and connect to the Orange Line and LA River.

The project includes new and improved sidewalks, crosswalks, bike lanes, traffic-calming measures on local streets, trees, shade structures, pedestrian lighting, and more. The project area is centered around the Sherman Way Orange (G) Line Station, and includes improvements on Sherman Way, the Orange Line Path, Owensmouth Avenue, Variel Avenue and Valerio Street.

This Fall, the City will be applying for a State grant to fund this project, which builds upon an earlier urban cooling community-based planning process led by Climate Resolve and Streets LA.
