MOTION: The City of LA Bicycle Advisory Committee requests that the following be taken into consideration in Los Angeles' landscaping and site design standards:

1. Assure that site plans include safe, convenient connectivity for bicycles to nearby bikeways, as well as roads and streets used by cyclists,

2. That site plans require the placement of bicycle parking in locations that are the least susceptible to theft, as close to building entrances as possible and where there is frequent pedestrian activity, and,

3. That site plans provide for expansion space for bicycle parking over time as demand grows.
