The LABAC General Meeting faced a shortage of quorum, delaying official business. Michael Schneider provided updates on the HLA draft standard elements guide, urging public comment on February 13. He highlighted Streets for All's election successes and ongoing projects, including the Bona Creek bike path extension, which may receive regional funds. Kevin Burton discussed the need for better bicycle infrastructure and emergency evacuation plans, emphasizing the importance of alternative transportation. Elliott from LADOT provided updates on the Northfield gap project, noting construction delays and ongoing outreach efforts. The meeting also touched on the LA River equestrian bike path and Sepulveda basin bike path, with further discussion planned.

Introductions and Meeting Kickoff
